

## Dedicated resistance

The Alliance for Democracy is a loose association of friends, which works independently, nationally and interdenominationally to prosecute legal and constitutional violations by politics and business ([www.menschenfuerdemo-kratie.de/kampagnen](http://www.menschenfuerdemo-kratie.de/kampagnen)). We believe that the debt policy must come to an end in early currency reform, so that social justice for all remains possible and necessary reforms can take place. In this sense, we can see no benefit in the Euro rescue, as it is currently aimed for by the government of Germany and the governments of the other countries of the euro zone. The cover-up of the scale of the disaster is even worse than the fact of the declining value of the Euro. Following the decision of the Federal Constitutional Court on the ESM, we also raised complaint against it and submitted further constitutional complaints, and requested the Constitutional Court to call on the Federal Government to lodge a complaint with the ECJ against the ECB (2 BvR 2214/12, 28.9.12), or more accurately against the decision of the European Central Bank of 6.9.2012 on the unlimited purchase of government bonds on the secondary market. Such a purchase would involve unsecured claims with no guarantee of any maintenance of value. Claims by the Bundesbank also exist in the amount of over € 700 billion (so-called target claims), which must be considered as extremely risky and unrecoverable. Apart from the fact that Germany is no longer able to pass a realistic budget (the budget for the year 2013 is doctored, see [http://menschenfuerdemo-kratie.de/index.php?lang=de&page=campaigns/20\\_verfassungsbeschwerde\\_esm\\_nachtrag.html](http://menschenfuerdemo-kratie.de/index.php?lang=de&page=campaigns/20_verfassungsbeschwerde_esm_nachtrag.html)), Germany is being drawn ever deeper into the debt spiral, and is violating the German Constitution by supporting such decisions, because Germany must in this way be held liable for the debts of other countries. This is unconstitutional and anti-democratic.

Nor is it any help if ECB President Mario Draghi wants to defend his policy before the German Bundestag, since this is again an infringement of democratic agreements, because speaking in front of the Bundestag is reserved for members of parliament or heads of state, in order to demonstrate the sovereignty of parliament and its special rights and obligations.

Our constitutional complaint is attached. We call on you in the interests of realistic reporting, which is worthy of the reader, to report on this complaint, because in this case, Mrs. Merkel has turned against herself. Government policy and the will of the people are drifting further and further apart – you should be reporting on the legal consequences of such actions. Do not continue to protect in this way a policy designed solely to preserve the political parties, which weakens the Euro and degrades the German economy to a supplier of goods for which it can no longer expect to be paid. In addition to a national crisis, this is the first step towards an industrial economic crisis which destroys jobs, hinders trade etc. Readers have the right to be informed about this; the press has the duty to report on this, everything else is injustice!
