Dear Mr. Miltner,

Please understand also that we would like to know why this advertisement has been refused by your management. We believe that the income from such announcements is very much in the interests of your management, and your differentiation by such screening constitutes a contravention of the basic right of free expression of opinion. Publishing and press companies defend themselves against attacks on the freedom of the press, which is also based on the right of freedom of expression according to the constitution. If you do not want such intervention in your affairs in your sector, how can you presume to try and restrict the basic rights of people in this country, some of whom are even subscribers to your newspaper. You are of course free at any time to reject advertisements. But this requires, within the bounds of your hopefully democratic conscience, thorough and specific grounds, which can serve as the basis for discussion in a free order. Alliance for Democracy will act in the strongest possible way against such restrictions, and will undertake corresponding activities to oppose restrictions by any persons or institutions, in a free market economy, by publishing companies for the purposes of economic and political lobbying. Our movement includes many subscribers to your newspaper. These persons have no understanding for the obtuseness of your actions. We thank you in advance for your conclusive response.
